On 3/27/2021, at approximately 2140 hours, PSC Officer Mendez #908 and I were working an overtime detail (Basketball game) at Pensacola State College, located at 1000 College Blvd., Pensacola FI, 32504 (Building 3) in Escambia County.

It should also be noted that during the men's game, a disturbance between a TCC athlete, identified as Shawn Walker #22 and PSC athlete, identified as Brent Thompson #0, occurred on the court. Thompson was elbowed in the face by Walker causing a verbal altercation that was separated by players and referees prior to any more physical attacks. During this game, there was heightened emotions from all athletes, coaches, and the crowds. Due to the atmosphere of the game,, Officer Mendez and I remained inside the gym during the entire game. Officer Mendez and I took separate corners incase a fight occurred.

At the time of this incident, Officer Mendez and I had just completed our routine to secure all entrances and exits to Building 3 and escort non-athletes out of the gym. The men's basketball game between PSC and Tallahassee Community College had just ended. It should be noted that the men's basketball games between TCC and PSC had always been an issue with heightened emotions, but never to this extent. This basketball game was the last game of the season for PSC, and was titled "Sophomore Night", therefore a few of the PSC basketball athletes were taking photographs with their families. Also, it was not uncommon for PSC athletes to remain in the gym after the games with their families and for follow up interviews with media. It also appeared that the parking lot had emptied out from vehicles and spectators.

Officer Mendez and I began walking outside of Building 3. Once I opened the front entrance to Building 3, Officer Mendez and I were in the middle of a physical altercation between several individuals from both TCC and PSC, as well as several unidentified individuals. Officer Mendez and I became separated in the crowds as we both attempted

to dissolve the fight. The fight grew into a large crowd of 50 or more individuals, and several other fights began to break out and the crowd was uncontrollable. Vehicles began driving up with more individuals that were joining in on the fights. Verbal commands were not working, I was struck several times while attempting to pull individuals apart at which time I changed my department issued radio from PSC's channel to Pensacola Police Department's channel and requested immediate assistance. I also deployed my department issued O.C spray at which time individuals began running away, getting inside vehicles and leaving the immediate area. Ultimately everyone began separating as they felt the effects of the O.C Spray. It took several attempts of spraying O.C spray to fully de-escalate the fight. PPD responded to assist on separating all the fights that had broken out.

Once the situation had diffused, PPD advised to their dispatch that EMS was needed for individuals who were O.C sprayed and injured. I also notified Chief of Police for PSC of the situation. While assisting individuals that needed medical attention, PSC player, Terry Durham, attempted to reinitiate the fight as most of the TCC players were helping their players that were O.C sprayed. At this time, it did not appear that TCC players were fighting anymore. Coaches and other individuals helped separate the groups. TCC players went on the bus, and PSC players and their families were instructed to go inside the gym. Still, vehicles and other unidentified members were pulling up in vehicles or walking up attempting to fight. PPD helped escort several people away from the area.

Durham was still screaming verbal threats to TCC, hitting PSC property, and making a large scene. Durham was told several times by me and other individuals to go inside the gym in which Durham became more irate shoving myself and others out of the way. Individuals carried Durham inside Building 3. Durham was being non-complainant and kept escalating the situation. Durham is known for his temper on the team.

EMS units arrived on scene and treated all parties that needed assistance. PSC Chief Goley arrived on scene and was briefed of the incident. PSC President Dr. Ed Meadows arrived on scene and was briefed on the incident as well. Both Coaches, TCC coach and PSC Coach Pete Pena wished to pursue criminal charges. Officer Mendez and I split up and interviewed individuals. Officer Mendez took all other parties statements and information from TCC's side and I took independent statements from witnesses. It should be noted that PSC athletes did not want to provide statements and were asked several times.

EMS ended up transporting PSC athlete, Dexter McKenzie, to Sacred Heart for a head injury. McKenzie appeared to be disoriented on scene, and could not answer simple questions as to his birth date. EMS Run # 19.

Also, during the incident several bags that belonged to PSC athletes were believed to be missing. Witnesses told Coach Pena of the situation who reported the information to me. One bag was retrieved from an unknown location. No one came forward and reported missing items to police. TCC coach was aware of the situation and advised that no PSC property was located on the bus.

Also, after all witness statements were taken (see other supplements), Officer Mendez and I went to the PSC dorms where we attempted to take witness statements from the PSC athletes again. Durham became argumentative and irate again with officers. All other athletes, and unidentified parties that were at the dorms were quiet and just stood around. Durham continued to state "where were yall when I got jumped" and "yall didn't do anything to help". Durham punched the trash can and the lid flung off the can. Durham appeared to be the leader of the group because since Duhram was not going to provide any statement, none of the other players were going to either. Durham was stating "we handle it in the streets". At this point, it was pointless to argue or attempt to obtain statements. Coach Sagar stated that Durham was "hot headed" and needed to cool down. Officer Mendez and I then left the dorms to obtain a statement from McKenzie at Sacred Heart and get a status update on his injuries. (See other supplements for McKenzie's statement)

The entire incident was not captured on my department issued body camera.

Officer Gary and I were conducting our routine lock up of the building, after the Pensacola State College Boys Basketball game had ended. A few players from PSC were finishing up photographs with family and friends, and it appeared that the parking lot was stating to empty. Officer Gary and I were walking outside to lock up the main door when we saw that there was a group of Basketball players from Pensacola State College (PSC) and other unidentified individuals, along with a group of Basketball players from Tallahassee Community College (TCC) in a physical altercation. One of the coaches from TCC exited building and assisted Officer Gary, I to break up the physical altercation in the entryway of the building. The group then broke up in to multiple different altercations, which caused Officer Gary and I to get separated. One group ended up on the side of Building 20, the other group ended up in the parking lot of Building 3.

An incident which caught my immediate attention was when I saw Adrian Walker and Terry Durham being chased by three individuals, who I identified as TCC players towards building 20. I took off after the group, losing sight of Durham but saw Walker and the three TCC players beginning to fight. I deployed my department issued baton while yelling verbal commands for them to get back and to stop. I ended up in between Walker and the three TCC players, with my back was to the TCC players holding them back from attacking Walker and swinging my baton to keep Walker from lunging at the TCC players. At this time, I was stuck in the back of the head and back by the TCC players, as they were actively attempting to attack Walker. I continued to yell verbal commands, where at that time Walker took off running back to building 3. The three TCC players complied with verbal commands to stop after Walker ran off and began to walk back to retrieve their bags in front of building 3. At that time, I observed Multiple vehicles were pulling up to the side of building 3. I began walking back up to tell the individuals who had gotten out of their vehicles that they had to vacate the premises, when I saw a TCC player lunge at a PSC player, and that is when the Head Coach of TCC grabbed a hold of his TCC player leading him away to the parking lot attempting to get all of the players on the bus.

I observed a TCC Player trying to hit the phone down of one of the bystanders who was filming the fights in front of building 3, I intervened and was giving the TCC Athletes verbal commands to separate and get on the bus. At that time, I saw an unknown PSC Player get attacked and brought to the ground and the TCC Players jumped on top, while a few PSC players were trying to get them off along with Officer Gary, coaches and staff. At that point Officer Gary Pepper Sprayed the group fighting which caused the individuals to disperse. PPD then arrived on scene to assist and radio to their dispatch for EMS for those pepper sprayed and injured to get medical attention if needed.

PPD, Officer Gary and I got all the TCC players to get on to their bus. Durham was still threatening and yelling at TCC trying to initiate more fights. Officer Gary and I told all the PSC athletes to get into the building and stay there unless they needed medical attention.

Officer Gary and I then split up to interview witnesses and to gather statements. I took the statements from TCC and Officer Gary took statements from PSC witnesses. (see supplements)

Officer Gary and I went to the dorms after the fact to attempt to gather statements from the PSC players. When we attempted to talk to the boys, Terry Durham became very hostile asking us " where were you when I was getting jumped" and that "we did not do anything", he then hit the trash can and the lid went flying. Adrian and the others also denied writing statements.

Officer Gary and I then when to Sacred Heart Hospital to go retrieve a statement and check on the condition of Dexter McKenzie, which will be in supplement provided by Officer Gary.

The entire incident was not captured on my department issued body camera.

Witness 1, identified as Jesus Rivera (FL DL # R-160-424-84-011-1) provided the following sworn verbal statements: Rivera stated that he was not present during the initial altercation but saw all parties fighting. Rivera stated that

someone from the bus (identified as TCC athletes: Josh Rubio, Floyd Davis and El Ellis) tried to take his phone as Floyd Davis kept stating "don't film me". Rivera has no further information.

Rivera provided a video of the partial incident and was uploaded into Case Mangement as video #3.

Witness 2, identified as Luke Karaba Ohio DL # UE356228, provided the following sworn verbal statement that he believed "DJ", identified as PSC athlete Dexter McKenzie, was in a verbal argument with 4 unidentified players from TCC and then about "15 players walked up on him" and the fight started to break out. Unknown who threw the first hit or what the argument was about. Karaba also had a video clip from the incident and it was uploaded into Case Management as video #2.

Witness 3, identified as Douglas "Doug" Rogers (PSC Faculty member), stated that he did not witness the initial altercation but helped assist with de-escalating the fights once he saw Officer Mendez and myself in the middle of the altercation. Both parties were actively fighting.

Witness 4, identified as Chantry Holdman (FL DL # H435-101-85-3301), stated that he did not really witness anything except for when the TCC players attempted to take Rivera's phone and multiple people fighting. Holdman also had a video clip from the incident and was uploaded into Case Management, labeled # 1.

Witness 5, identified as Sonya Evans (FL DL # E152-792-65-9290), provided the following sworn written statements: Evans was speaking with Durham when pizza delivery guy pulled up. Evans walked off. Durham got into a verbal altercation with TCC players (unidentified). The TCC's entire team ran up on Durham and McKenzie and TCC started to beat them up and kick them in the head. Evans ran toward the fight to help pull people off and help get everyone in the gym. Evans then heard that her niece, Jada Crenshaw, got pepper sprayed. Evans went to assist Crenshaw get inside the gym. Evans then came back outside to see TCC still trying to fight PSC athletes.

Witness 6, PSC Coach Kapor Sagar stated that when he came outside "DJ" was in a headlock, with several people crowding around him as he was being punched and kicked. Coach Sagar identified one of the TCC players as Rubio #15 who was attaching "DJ".

Witness 7, Bus Driver for TCC Larry Darsey (GA DL#055434009), provided a verbal statement that he witnessed an unidentified person in white shirt and grey sweatpants reach inside their vehicle and grab a gun but the person could not be identified. Darsey could not describe the firearm and also stated that he believed it to be a gun based on the motions the individual made. Darsey stated the person was never seen again nor could he point the person out.

It should be noted that the three individuals that were believed to have a firearms were friend's of McKenzie's girlfriend, "Bri", but they had no firearms on them as they pulled their shirts up and were showing law enforcement that no firearms were present. The individuals had left prior to statements being taken. The one that possibly had the firearms in the white shirt and red sweat pants was identified as a person named "Luke". No other information could be found on the individuals.

PSC coaches were able to obtain witness statements from PSC athletes after the fact on 3/28/2021 and were later emailed to Officer Mendez and I.

Below are the following statements from the PSC athletes:

Witness 8, PSC athlete Benjamin "Ben" Turner (AR DL# 939442779) provided the following written statements: Turner was walking to his vehicle when he witnessed about 5 TCC athletes fighting PSC athlete Durham, PSC athlete Brent Thompson, and PSC athlete McKenzie. Turner helped assist police and faculty members by pulling people off. Then everyone was pepper sprayed. PSC athletes then got in the back of Turner's truck and left the scene. Turner identified TCC athlete, Deangelo Ware as one of the players fighting Durham which caused Durham to fall from his crutches. Other players that were identified as actively fighting from TCC's side were Etan Collins, Breon Thompson, Tyler Poindexter, and Amir Gholizadeh.

Officer Mendez and I also went to Sacred Heart to get McKenzie's statements on 3/28/2021 at approximately 0100

hours. McKenzie provided the following statements: McKenzie stated that he was walking to his vehicle that was parked in Lot N when he witnessed a TCC athlete (unidentified) was "trying to get at Terry (Durham)" and he saw people chasing other people down the street. McKenzie stated that those statements were all that he could remember. McKenzie stated that he could not remember loosing consciousness but witnesses, such as Evans, stated otherwise. Evans stated that McKenzie lost consciousness. McKenzie stated that his friends carried him inside Building 3.

McKenzie's injuries were documented and uploaded into Case Management. McKenzie's mom, Stacy McKenzie, advised she would send me an email of McKenzie's medical reports for the report. McKenzie has a follow up doctor's appointments with a neurologist and was diagnosed as having a mild concussion. McKenzie was released from the hospital on 3/28/2021. Stacy McKenzie was not present for this incident.

Coach Sagar provided photographs of Walker's injuries on 3/29/2021 and were uploaded into Case Management. It should be noted that Walker did not want to provide a statement.

Thompson and Durham also refused to provide statements as well.

On 3/29/2021, Coach Sagar was asked to retrieve information from the Domino's employee, identified as Cameron Feathers, who was present during the beginning of the altercation. Coach Sagar had Feathers complete a witness statement as the coaches were helping retrieve statements from the incident. The statement was uploaded into Case Management. The statement provided names of both TCC player, Ware, and PSC player, Durham. Being that names were listed in his statement, I contacted Feathers via cell phone to get a verbal statement as to how the names were identified. Feathers provided the following verbal statements: Feathers was not sure where to go on campus so he pulled to the front door of PSC's Building 3. Durham approached Feathers and asked if the pizza was for PSC. Feathers stated the pizza was not and stated that Ware was there on behalf of TCC to retrieve the pizza. Durham began a verbal argument with Ware as he "slicked off at the mouth" and everyone began arguing. Feathers then stated that someone in a "red hoodie" swung first. Feathers believed it was a person from TCC but was not sure. Feathers stated that the coach from TCC interviewed him on scene and identified the names to him which was how he knew the names. The TCC coach, unidentified, then told Feathers to leave in which he did. Feathers knew a second fight broke out but was not sure who initiated that fight. Feathers stated that all he wanted to do was leave.

It should be noted that the individual seen on the video footages of a person in a red hoodie was identified as McKenzie. Another individual that was in a red hoodie was not identified but was seen as a person walking away and standing at the front doors, not actively participating. Feathers still has not been told the name of the individual who was in the red hoodie, Feathers just knew that Durham did not swing first so he believed that person in the "red hoodie" was Ware based on the names the coach provided to him (which is what his statements read).

On 3/31/2021, I made contact with McKenzie and Evans in attempts to identified Crenshaw. Crenshaw was not identified through police databases. McKenzie and Evans advised they would have Crenshaw contact PSC Police for further information regarding this incident.

The request for Pensacola Police Department's body camera footage was sent out on 3/31/2021.

It should also be noted that the building cameras to Building 3 were offline during this incident and no footage captured the incident per PSC dispatch.

I collected multiple witness statements from the TCC athletes and coaches and one PSC athlete as well as received some from the PSC athletes from Coach Kapoor after the fact.

The first individual I spoke with was the head coach of TCC Zachary Austin Settembre, who provided me with a sworn written statement. In his statement he stated, Tallahassee CC men's basketball team was jumped outside the Hartsell Arena. Settembre advised that it all began when the Dominos Pizza delivery driver asked if they were Tallahassee, which they stated they were. Settembre stated that Terry Durham told them that "They aren't getting

shit, bitch. Fuck you N___". Settembre advised that after Terry Durham said that, one of his players responded and asked "who are you talking to" where then Durham responded with "I'm talking to you bitch". Settembre stated that then Durham's team mate Dexter McKenzie threw a punch at Floyd Davis (TCC Player). Settembre said that the female that Dexter was with began throwing punches into the crowd. Settembre advised that more people associated with PSC then joined in saying racial slurs and pushing then fighting broke out.

When I was handing out the witness statements Settembre the head coach of TCC was attempting to speak with DeAngelo Ware before he began writing his statement, which should be document on my department issued body camera. The other Delmar Ali who also provided a statement after was talking with Head coach before his statement.

The second individual I spoke with was DeAngelo Ware, one of the TCC athletes, who provided me with a sworn written statement. In his statement he advised that after the basketball game, he walked outside to grab the food that the team had ordered when he was called out by his name by Terry Durham. Ware stated that Durham and two females and the TCC basketball team started saying words. Ware advised that Dexter McKenzie then rushed out the building and approached the TCC players. Ware stated that McKenzie and two females swung on players and that the TCC team defended themselves. Ware said that he was held by another player on his team.

The third Individual I spoke with was Delmar Ali, another coach for TCC, who provided me with a sworn written statement. Ali stated that he walked out the front entrance where he saw an argument between TCC and PSC players. Ali advised that he got in between the group when Terry Durham then dropped his crutches and Dexter McKenzie told one TCC player to "step out". Ali stated that that is when McKenzie and a female took a swing at TCC player Floyd Davis and that his players reacted badly and began to fight. Ali advised that himself, Officer Gary and I, were trying to break up the fight but other players from PSC began joining in and that it was getting out of control. Ali said that Officer Gary had to mace the athletes and that Dexter, Terry and Adrian were taking cheap shots at the TCC players who had been sprayed. Ali stated that a friend of Terry and Dexter had a firearm and no one said anything but backed up.

The fourth individual I spoke with was Floyd Davis, a TCC athlete, who provided me with a verbal statement. Davis stated that the argument began over the Domino's pizza. Davis advised that Terry Durham said to the TCC players "I'm going to put you in the dirt". Davis stated that he tried to calm people down when the guy in the red jacket and girl in jumpsuit swung at him, and that both teams started fighting.

The fifth statement I received was from Noah Croak, a TCC coach, who provided me with a written statement. Croak advised that they were told a fight was happening and that there were a group of TCC and PSC players along with PSC woman's team and fans in a brawl. Croak advised that Terry Durham and Dexter McKenzie were pursuing TCC's team and that the TCC team reacted. Croak state that he heard McKenzie yell to an individual running up to "get the guns" and that he saw Adrian Walker swing on DeAngelo Ware and Ware got Walker to the ground as staff tried to break it up. Croak stated that a female officer then pepper sprayed the whole group. Croak advised that Walker than ran away and Durham kept pursuing anyone in his path along with multiple females and fans. Croak stated that TCC men's team then got on bus.

The sixth witness statement that I received was from Bijon Sidhu, a PSC athlete, who provided a written statement. Sidhu stated that DeAngelo Ware jumped his teammate that was on crutches and that then all but two members of the TCC team began beating three of his teammates. Sidhu stated that there were about 12 TCC players Vs 4 PSC players. Sidhu advised that he then ran outside when he heard his teammates screaming and that some PSC players were on the ground getting stomped by D.W, J.K, A.G and many others from the TCC team that he could not identify due to being pepper sprayed. Sidhu said that D.W was the first person to start fighting and that he brought his other teammates to help him. Sidhu stated that his teammates that were getting beat where just minding their own business.

Officer Gary and I received statements from PSC Players from Coach Kapoor after the incident. The statements I received were those of Josh Williams and Cheickna Sissoko.

The first statement I received was from Josh Williams, a PSC athlete, who provided a written statement. Williams stated that he got a phone call saying his teammates were getting jumped, and that himself and three others ran

outside to see Carie, Brett, Terry, and Dexter getting jumped. Williams stated that Adrian Walker was getting choked out and that BT and DJ were getting stomped by 3 of 4 TCC players. Williams said that himself and Bijon tried to do as much as they could to get the guy out of there safe but then they were spayed with pepper spray directly.

The second statement I received was from Cheickna Sissoko, a PSC athlete, who provided a written statement. Sissoko stated that himself and Ben Turner walked outside of the gym to go to their cars when they saw a lot of people fighting and that he recognized one of his teammates getting jumped by some TCC players. Sissoko advised that he ran to help his teammate ad then saw another one of his teammates screaming because he had been pepper sprayed. Sissoko said that he helped his friend Isaiah to his car and drove him back to the dorms. Sissoko advised that the guys that jumped his teammates were TCC players but he could not see their faces. Sissoko stated that he did not know which of his teammates was getting jumped but that people told him it was Terry Durham.

The video footages were reviewed. All three videos showed the same incident, from the same camera angles. Rivera's video footage had the best video from this incident. Below are the following findings:

- -Video was 5 mins and 17 seconds long.
- -The beginning of the video was where person in the red hoodie, identified as McKenzie, was being physically carried away from the middle of the road by a group. A second person was seen in a red hoodie as standing by, outside of the group. McKenzie was wanting everyone to let him go but a female, identified as "Bri" McKenzie's girlfriend was telling him to chill out. There was second small kids with her in the middle of everyone fighting.
- -The camera points to the ground, and you hear a man's voice screaming I live in Tallahassee as "Bri" yells at him to call down. The voice is believed to be McKenzie.
- -The camera then refocuses and you see a large crowd in the trees fighting but cannot make out who the parties are. You see a female in a light pink hoodie, identified as Jada Crenshaw, running from the crowd toward the entrance of Building 3. Crenshaw is the niece to Evans which Evans was the mother of McKenzie.
- -Another you see the individual in another red hoodie, unidentified, walking toward Building 3 staying away from the altercation. This person was also with McKenzie's family.
- -The fight is still going on and you see Crenshaw run back into the group.
- The video points toward the ground, but you can hear Durham (who I personally can identify through his voice) stating "yall walk up on" and "talkin bout go Terry". Durham also continues to be verbally loud yelling "yall gotta be fucked up" and continues yelling through the entire video.
- -In the background of the video, you see Crenshaw throw a punch at someone but could not see who the other party was.
- -Durham then enters back into the camera's view trying to start another fight with TCC player, Amir Gholizadeh, that is being held back by his coach. Gholizadeh was actively trying to fight Druham back.
- -Then Crenshaw walks up and punches Gholizadeh in the side of the head and runs away. Gholizadeh tries to go after Crenshaw.
- -Then several TCC players attempt to take the phone from Rivera. The players were identified as Josh Rubio, Floyd Davis, and El Ellis. These TCC individuals attempted to fight with Rivera but others, including Officer Mendez, removed them from the area.
- -In the background, you can see another fight taking place in the parking lot.
- -You are not able to make out who was involved, but could see one person stomping on someone's head at which time I began pepper spraying individuals.
- -Individuals then began to disperse. PSC players are seen in the background getting inside a truck and leaving as PPD units pull up.
- -Next part of the video is everyone dealing with the aftermath of OC spray injuries.
- -TCC players identified as Gholizadeh and Kendell stood around to continue fighting but Rivera told them to go get back on the bus in which they did.
- -Next you see myself herding PSC people back inside the gym to separate the parties.
- -The video ends as you hear Durham becoming irate wanting to go fight again.

The other video footages show the same footage in smaller clips.

At this time, the information will be sent to the State Attorney's Office to determine if any criminal charges would be pursued in this incident. The recommendation is to pursue charges of Florida Statute Affray 870.01(1) which stated that fighting or affray occurs when two or more people engage in a fight in a public place which leads to the terror of the people. The following suspects have been identified so far: McKenzie, Crenshaw, Walker, Druham, Davis, Floyd, Rubio, Ware, and Gholizadeh.

It should also be taken into consideration that the individuals have now completed basketball season, and several individuals live outside of the Pensacola area and several individuals will be returning home and/or attending another school next semester when determining extradition if charges are pursued.

It should be taken into consideration that this incident resulted in the use of force (through less lethal alternatives - Baton and O.C. Spray), the utilization of another law enforcement agency (Pensacola Police Department), and also resulted in someone being transported to Sacred Heart Hospital for a head injury (Dexter McKenzie).

On March 30th, 2021 at 0836 hours I received an email from Rob Chaney the Director of Athletics at TCC (who was not present during his incident) containing ten new witness statements written two days prior to the incident along with new statements from individuals who had already given statements at the scene. It will be noted that there are multiple discrepancies in the second statements and will be uploaded to case management.

The new statements received were from: (waiting to receive ID cards from these individuals)

Imhotep George (player)- stated that Terry Durham is the individual who initiated the altercation followed by Dexter McKenzie and 2 other females. He stated that the first punch was thrown by a female.

Joshua Rubio (player)- stated that he was going to get pizza and saw 2 of his teammates and one PSC player with 2 females, arguing over the pizza. stating that the "female cops" were doing nothing and just sprayed people and that the PSC coaches ran away.

Leah Hutchins (manager)- Stated that herself and 2 TCC basketball players (DeAngelo Ware and Christian Hampton) were going to get their pizza when Terry Durham said "you ain't getting shit,bitch". She stated that she tried to restrain Ware to de-escalate the situation. She stated that Dexter and a Female swung first. She said that only the TCC players got the majority of the spray.

Malique Calixte (manager)-Stated that he was walking out to get pizza and heard Terry Durham start yelling at them along with a female. He stated that the female threw the first punch, so he ran inside to get coaches.

Mandela Baledrokadroka (player)-Stated that after he got changed he went to go get pizza and he saw Terry Durham talking to his teammates and threatening DeAngelo Ware. He stated that the "policewoman" did nothing and that and "older white man" had his teammate in a head lock and that he then got sprayed in the face.

Timothy Cox (coach)-Stated when he heard what was going on outside he rushed out to see 10-12 people in an

altercation. He stated that more people were trying to break it up than in it. He stated that the individuals he saw in the altercation were DeAngelo Ware, Breon Thompson, Josh Rubio and Floyd Davis from his team and from PSC it was Dexter McKenzie and Adrian Walker. He saw multiple people then get pepper sprayed.

Etan Collins (player)- Stated he was going to get their pizza, when he saw one of his teammates and one PSC player verbally arguing, then more PSC players came up. He stated they were yelling death threats. He said after the first punch was thrown all the TCC players were trying to get on to bus. He stated he heard people yelling for guns.

Tyler Poindexter (player)- stated that he was walking out of the building when he heard Terry Durham and his teammate DeAngelo Ware arguing. He stated he went back inside to get water bottles when he saw Dexter McKenzie run out. He stated that the team had not other choice but to fight back. He stated he went to split up 4 guys and he gets punched in the jaw by a female. he stated that then an Officer sprayed and he heard people stating they had guns. (let it be noted that in Coach Noah Croaks second statement it says that Poindexter was not involved and on the bus)

Breon Thompson (player)- he stated that the players were going outside to get their pizza, and he heard Terry Durham yell. He said Dexter and his girlfriend rushed the players and fights broke out.

Neal Darsey, bus drive, Astro Travel & Tours - This statement was written by a third party, the actual statement was captured on Officer Gary's body camera.

After reviewing all statements given, it should be noted that they all opened up with them getting pizza and ended with officer spraying pepper spay. It should be also noted that all the quotes in each statement are identical whether they were outside or inside building and description of the female who "threw the first punch". It should be documented that Each statement has similar accounts of actions and words what were said throughout the fighting.

The updated statements: Noah Croak DeAngelo Ware Zachary Settembre Floyd Davis

After reading the new statements (that were sent to their school board), the second statements given by Noah Croak and Zachary Settembre had major discrepancies from their first sworn statements. In Noah Croaks statement its says verbatim "Tyler Poindexter- on the bus, assisting guys with removing pepper spray, did not attempt any malicious nature.", but I received a statement from Poindexter stating that he was involved and not on the bus. Another discrepancy is Noah Croak stating that DeAngelo Ware was "Deangelo Ware- walking to bus, hit in head by Adrian Walker, held Adrian Walker in a choke hold until he was forced to let go by police.", when in his statement he states that he was involved with the fight with Terry Durham and Dexter McKenzie. It is also documented by the Domino's delivery guy and with all other witness statements.

In Zachary Settembre's second statement contains false accusations that will be proven by video footage, as well with sexist remarks, along with adding multiple details that were not in his first report.
